

PARKWAY PLAZA RESIDENTS

Each resident of Parkway Plaza is eligible for a bus pass allowing unlimited use of CATA's CENTRE LINE "R" Route service. Please read these instructions for obtaining a pass:

ON-SITE DISTRIBUTION TUESDAY, AUGUST 11 & MONDAY, AUGUST 24, 2009 11:00 a.m. – 4:00 p.m.

- CATA staff will be at Parkway Plaza from 11:00 a.m. until 4:00 p.m. to issue passes on Tuesday, August 11th and Monday, August 24th. Passes will not be available for issue at either CATA office locations before August 12th.
- Please allow 10 minutes to receive your pass depending on the amount of people waiting.
- Pass distribution will stop promptly at 4 p.m., so arrive early enough to allow sufficient time to process your pass.
- Please bring with you both the white and yellow copies of a completed Authorization Form, signed by your rental office along with one form of photo ID (driver's license, PSU ID, etc.) and your bus pass from last year (if applicable) to be turned in when you obtain your new pass.

If you do not obtain your pass on-site on Tuesday, August 11th, you may wait until the next on-site distribution on Monday, August 24th, or pick up your pass, after Wednesday, August 12th, at either CATA office. Listed below.

OFF-SITE DISTRIBUTION: AFTER WEDNESDAY, AUGUST 12, 2009

- Please bring with you one form of photo ID (driver's license, PSU ID, etc.)
- Both the white and yellow copies of a completed Apartment Pass Authorization Form, signed by your rental office.
- Your bus pass from last year, if you have one, to be turned in when you obtain your new pass.

If you do not have identification, or both the white and yellow copies of the Authorization form, or Authorization forms properly signed by your rental office, we cannot issue your pass, so please make sure you have these items with you.

If you already have a current Parkway Plaza "R" route pass, it will expire on August 31, 2009, and you may use it until then if you don't obtain a pass for the new year before that date. However, as of September 1, 2009, only a new pass will be accepted for bus service and you will be required to pay a fare of \$1.25 without it. Please note that your apartment lease or Apartment Pass Authorization form will not be accepted for bus service at any time.
